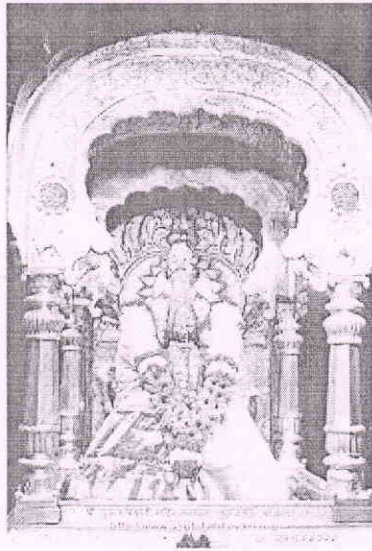

## **SCOPE OF WORK**

The temple trust is in the process of implementing a temple-wide project for the computerization of the temple by deployment of an Enterprise Resource Planning (ERP) software and hence it invites eligible bankers, industries, companies for this Expression of Interest on CSR basis.

Temple management (Integrated Temple Management System) is one of the fundamental delivery of service enablers of the devotees and temple. In addition to the core functions of channelizing the services of Seva, Bhakti Niwas, and Donation the trust is also entrusted with a huge financial management activity of Treasury, Receipts of Donations, Auctions, Management of Support Staff, Contracted Employees, Payroll and Payouts of contracted and permanent Employees,

Asides this the standard functionality for the Queue Management, Crowd Management, Alerts and Announcement, Slotted Darshan, Website, Data and Media

streaming which are standard functions. The Temple Trust has decided to build a completely integrated solution that will handle the various needs of the temple from Financial Management, HRMS, Payroll, Operations Management, Monitoring, and daily reporting, MIS,

The trust intends to follow the global best practices relating to the software development lifecycle which includes business requirement gathering, solution documentation, solution architecture, system integrator, UAT, and continuous improvement in production. Additionally, The Trust is at various stages of embracing agile software development and DevOps / DevSecOps while the service provider shall be developing the first cut of the software on its own. It is expected to follow the discipline in conformity with the intended best practice delineated above.
